

WASH ME SOLAR PRIVACY POLICY
EFFECTIVE JULY 1, 2021

This Privacy Policy (the “**Policy**”) covers Wash Me Solar, LLC, a Utah limited liability company (“**Wash Me Solar**”, “**we**”, “**us**”, or “**our**”) and describes the types of information we gather from people visiting www.washmesolar.com (the “**Site**”) and using our products (the “**Products**”) and services (the “**Services**”), and how we use such information. By accessing the Site and using our Services, you agree to be bound by this Policy. If you do not agree to the terms of this Policy, please immediately exit the Site and do not use the Site or our Services. Each time you use the Site or Services, the current version of the Privacy Policy will apply. Accordingly, when you use the Site or Services, please check the date of this Policy (which appears at the top) and review any changes since the last version.

TYPES OF INFORMATION WE COLLECT

WASH ME SOLAR may collect two types of information from users of our Site and Services: “**Personal Information**” which is information that can be used to locate you, contact you, or determine your specific identity (such as name, e-mail address, mailing address, phone number, etc.) and “**Aggregate Information**” which is information about your activities on the Site or in connection with the Services that cannot be used to identify, locate, or contact you.

COLLECTING YOUR PERSONAL INFORMATION

Wash Me Solar collects Personal Information that is voluntarily provided by a user. In particular, when you sign up for an account, we ask you for certain personally identifying information such as your name, email address, and physical address, among other information. This information is used to assist us in analyzing the feedback and in facilitating your use of the Site or Services.

COLLECTING YOUR AGGREGATE INFORMATION

Aggregate Information is collected as you visit our Site or interact with our Services and Products even if you do not enter any information. Generally, Aggregate Information is used in a collective manner, and no single person can be identified by that compiled information. Wash Me Solar uses Aggregate Information to provide its Services and Products, as well as to determine the use of our Site and to monitor, audit, and analyze information pertaining to our business metrics. Further, Aggregate Information may and can be used to determine trends.

SHARING, SELLING, AND TRADING OF YOUR PERSONAL INFORMATION WITH THIRD PARTIES

WASH ME SOLAR will not share, sell, or trade your Personal Information with third parties except as needed as we deem necessary for a third party to fulfill their duties, such as fulfilling orders, processing credit card payments, or other functions necessary to our business. When you submit your Personal Information, you also agree that we may use your Personal Information to contact you by email, telephone, cell phone, direct mail, or text message about certain offers made available by us or third parties that we believe you might be interested in based on information you have provided to us.

Ultimately, we simply use your Personal and Aggregate Information in an effort to improve your experience on the Site and with the services, and to communicate with you about information that you request. We may also use this information to help us develop and improve the Site and Services, and to tailor our Site and Services to your interests.

SHARING, SELLING, AND TRADING AGGREGATE INFORMATION COLLECTED ONLINE WITH THIRD PARTIES

Aggregate Information may be used to improve the Site and Services, to monitor traffic and general usage patterns on the Site, and for other general business purposes which we determine at our sole discretion. Thus, we may disclose or sell Aggregate Information to third parties for a variety of business reasons. Aggregate Information will not include any Personal Information and we will not disclose any Personal Information except as expressly stated elsewhere in this Policy.

OTHER DISCLOSURES OF INFORMATION

Notwithstanding the foregoing, Wash Me Solar may elect to share or transfer your personal information to unrelated third parties for any of the following reasons: (i) to comply with a legal requirement, judicial proceeding, court order, or legal process served on Wash Me Solar; (ii) to investigate a possible crime, such as fraud or identity theft; (iii) in connection with the sale, purchase, merger, reorganization, liquidation or dissolution of Wash Me Solar; (iv) when we believe it is

necessary to protect the rights, property, or safety of Sun Elevated or other persons; or (v) as otherwise required or permitted by law.

It should be noted that on some portions of the Site, users can choose to have their Personal Information displayed. If users choose to have their Personal Information displayed on the Site, Wash Me Solar shall not be responsible for this disclosure and such display shall not be considered a breach of this Policy.

COOKIES

We may also use “cookies” and your Personal Information to enhance your experience on the Site and to provide you with personalized offers. A cookie is a small data file placed on your computer’s hard drive that contains information that allows us to track your activity on the Site. The cookie itself does not contain any Personal Information; however, if you provide any Personal Information to us, the cookie may act as an identifier to tie your Personal Information to your IP address or computer. You may choose to delete cookies from your computer’s hard drive at any time or to disable cookies on your computer. If you delete cookies that relate to the Site, we may not be able to identify you upon your return to the Site. Additionally, if you disable your computer’s cookies, you may not be able to access certain features of the Site that require that cookies be enabled. The Site’s cookies cannot be used to read data from your hard drive and cannot retrieve information from any other cookies created by other websites. Additionally, our cookies cannot be used as a virus, Trojan horse, worm or any other malicious tool that could impair your use of your computer. Our cookies are used to help us better understand how you and other users use the Site so we can continue to provide a better, more personalized user experience on the Site.

POLICY CHANGES

We expressly reserve the right to change this Policy from time to time without notice to you. You agree that it is your responsibility to review this Policy from time to time and to familiarize yourself with any modifications. Your continued use of the Site and/or Services indicates your consent to our collection of and use of your Personal and Aggregate Information under the then current Policy.
